The seller and buyer acknowledge that from time to time variation fees, transaction fees, and other fees, may vary and the buyer agrees that Veritas Training Group will not be held responsible for any fees other than agreed set up costs, transaction fees and default fees, incurred by the buyer including but not limited to: bank charges, debt collection, variations, commissions, fines or penalties from other institutions including Veritas Training Group, transaction fees or any other fee without prior written agreement from the Seller known as Veritas Training Group.

This is a binding agreement which shall not be cancelled by me (The Buyer), until the total fees have been paid by me (The Buyer) via the Veritas Training Group "BECS" Schedule above or an alternative method of payment agreed to by The Seller and The Buyer.
