# Agreement for Sale of Goods & Services

This agreement is made by and between Veritas Training Group of PO Box 4807, Robina TC Qld 4230 as identified by the ABN and the buyer as detailed in writing and signed by the authorised buyer, located in this agreement, and described below.

It is agreed between the parties that:

- 1 The Seller agrees to sell, and Buyer agrees to buy the following described goods and/or services:

- 2 The Buyer agrees to pay to The Seller and The Seller agrees to accept the total purchase price for the goods and/or services of Aus \$..... (*Insert course fee total amount*) payable as follows:

The buyer is empowered to authorise deductions from this account and irrevocably authorises Veritas Training Group, holder of "BECS" (ID Number .....) ("the Collection Agent") to collect payments by way of automatic deductions from the account in accordance with the Direct Debit Authority.

- 3 The Buyer acknowledges that he/she is indebted to Veritas Training Group the total purchase amount and has agreed to satisfy the debt for this purchase by making payments as set out in the "BECS" schedule. The Buyer further acknowledges that he/she understands the terms and conditions as set out in the "BECS" Schedule Direct Debit Authority.

- 4 The Buyer acknowledges that the Collection Agent is the agent of NSW College of Training t/a Veritas Training Group for purposes ONLY of the collection of the payments

- 5 Veritas Training Group warrants it has full legal title to the said goods and services provided, authority to sell same, and that said property shall be sold free and clear of all liens, encumbrances and claims.

- 6 The Buyer acknowledges that the authorisation to the Collection Agent may only be cancelled by way of a written direction signed by both the Buyer and the Seller authorising such cancellation.
- 7 There are no express or implied warranties or conditions, representations, statements, whether implied by statute or otherwise, not is there any collateral agreement or promise, relating to the sale of goods and / or services and any such warranties, conditions, representations, statements, collateral agreements or promises are, to the extent permitted by law, excluded from applying it to the sale of the goods and / or services under this agreement.
- 8 Until the Buyer shall have paid for the goods and/or services in full, that Veritas Training Group may retain title to the same goods and or services and if payment is not made when due The Buyer authorises the seller by its servants or agents to collect monies and / or valuables for the purpose only to re-cover the cost of goods and / or cost of collection and / or services provided to and purchased by The Buyer. In this situation no refunds of the amounts collected as part payment will we reimbursed to The Buyer from The Seller.
- 9 This agreement shall be binding and inure to the benefit of the parties, their successors, assigns and personal representatives. Any part of this binding agreement that may be deemed legally enforceable shall not revoke the remainder of this agreement.
- 10 The buyer is wholly indebted to Veritas Training Group. Should the buyer fail payments, the buyer acknowledges an irrevocable approval for Veritas Training Group to add to the debt incurred a recoverable additional twenty percent to the fees outstanding.
