### 1. POLICY

This policy outlines the expected conduct of both students and staff regarding the use of Artificial Intelligence (AI) in academic activities at Veritas Institute Australia.

It emphasizes the importance of maintaining academic integrity while engaging with AI technologies.

### 2. PURPOSE

This policy establishes guidelines for students and staff regarding the ethical use of Artificial Intelligence (AI) at Veritas Institute Australia. It aims to ensure a fair and transparent learning environment that upholds academic integrity.

### 3. SCOPE

This policy applies to all students and staff members of Veritas Institute Australia involved in educational activities that utilize AI technologies.

### 4. GENERAL CONDUCT GUIDELINES

- a. Honesty and Integrity
  - i. Students and staff are expected to maintain honesty and integrity in all academic activities, whether traditional or involving AI technologies.
  - ii. Plagiarism, cheating, and unauthorized collaboration are strictly prohibited.
- b. Responsible Use of Al
  - i. Students and staff should use AI tools responsibly, adhering to the principles of academic integrity as per Plagiarism Policy and Associated Procedures.
  - ii. Any use of AI to gain an unfair advantage in assessments or academic work is considered a violation of this policy and the Plagiarism Policy and Associated Procedures.
- c. Respect for Privacy
  - i. Both students and staff are expected to respect the privacy of others when utilizing AI technologies.
  - ii. Avoid sharing sensitive information or using Al tools to access unauthorized data.
- d. Data Protection
  - i. Staff should ensure that AI tools used in educational settings adhere to data protection standards and prioritize the security of student information.

### 5. STUDENT CONDUCT

- a. Use of AI in Assignments and Assessments
  - i. Original Work: Students are expected to submit original work, and staff should create assignments that encourage critical thinking and individual effort. Students must not use AI tools to gain unfair advantages, such as automated content creation for assignments or unauthorized assistance during examinations.
  - ii. The use of AI to generate or replicate content without proper attribution is not allowed.
  - iii. Academic staff and assessors of Veritas Institute Australia have the right to re-assess students or use other strategies including but not limited to a questions and answer session related to the unit of competency or content of the submission made to establish competency if students are suspected of use of AI in an appropriate manner.
- b. Guidance and Collaboration
  - i. Staff members are encouraged to provide clear guidelines on the use of AI in assignments and assessments.
  - ii. Students should seek clarification from staff and trainers and assessors if uncertain about the appropriate use of AI tools.



### 6. STAFF CONDUCT

### a. Transparency in Al Use

Staff members using Al technologies in educational activities must be able to provide clear explanations of how these tools will be used, ensuring transparency, and understanding among students.

### b. Fair Assessment Practices

Trainers and Assessors should employ Al tools for training purposes with human oversight, ensuring fairness, accuracy, and alignment with academic standards.

All Veritas Institute Australia's staff should avoid using Al in a way that could unintentionally disadvantage certain student groups.

### c. Educational Use of Al

Staff should leverage AI to enhance educational experiences, offering additional resources, personalized learning paths, and real-world applications without compromising academic integrity.

### d. Professional Development

All staff of Veritas Institute Australia are encouraged to participate in professional development programs to stay informed about the ethical use of Al in vocational education. Where possible, Veritas Institute Australia will provide and/or host such professional development sessions/ resources to staff.

### 7. CONSEQUENCES FOR VIOLATIONS

### a. Student Consequences:

Violations of this policy may result in academic penalties, ranging from warnings to revaluation of assessment submissions, and a requirement for re-submission or re-enrolment in the unit.

### b. Staff Consequences:

Staff members found in violation may face disciplinary actions, ranging from warnings to termination, depending on the severity of the offense.

### 8. EDUCATION AND AWARENESS

## a. Orientation and Induction Programs:

Veritas Institute Australia will include a copy of this policy on its website for all staff and students to refer to. Additional information will also be included in staff induction and student orientation resources in relation to Al ethics and academic integrity in orientation programs for new students and staff.

## b. Regular Workshops:

Trainers and assessors conduct regular mini workshops and training sessions to keep students informed about Al related ethical considerations.

# 9. REVIEW AND REVISION

This policy will be subject to periodic review to ensure its effectiveness and relevance in the context of Al and vocational education.

# 10. APPROVAL AND IMPLEMENTATION

This policy is effective upon approval. By adhering to this policy, students and staff at Veritas Institute Australia contribute to the creation of an ethical and supportive learning environment where AI technologies are used responsibly and in accordance with principles of academic integrity as outlined in the Plagiarism Policy and Associated Procedures.
